

A. RE: WARRANT TO ENTER 9 January 2008

- 1) RSPCA Inspector handed the Warrant to enter to me After quizzing me about my personal details, "what is your full name, date of birth, where were you born, do you live here on your own?, who else lives here? and when we came into my home watched by 2 Policemen, the other 2 ~~if~~ left before the quizzing.
- 2) Shortly after service of the Warrant, RSPCA Inspector Shayne Towers- Hammond came through the door & ordered "seize all the dogs". He repeated this at least once more as some people present hesitated & looked at him.
- 3) No one at this point has been close enough to inspect any dog or had put their hands on any dog.
- 4) The puppies & adult toy poodles were put into holding pens by me before I went out to greet them when I saw a continuous stream of vehicles coming into my property following the Police vehicles which had their lights flashing overhead.
- 5) Between the time I was being served the Warrant and Towers-Hammond's arrival, other RSPCA personnel were wandering into my home taking photos, lights flashing everywhere.
- 6) The 2 Policemen who watched L. Stageman serving me the Warrant, asked me whether I understood to allow them to do ~~their~~ their what they have to do without getting their way or I will go to jail. I said yes. The Policemen then left.

7) *Towers-Hammond recorded "Caution" at 4:40 pm just before he left my property. L. Stageman was present at the recording.*

B. RE: WARRANT TO ENTER 22 February 2008

- 1) RSPCA Inspector Shayne Towers-Hammond gave me the Warrant, the 2 Policemen said that they had been here before when I phoned the Police about being assaulted by strangers after RSPCA release to the Media TV & Newspapers defaming me, my poodles, my kennels, & I was not to get in the way... I said Yes.
- 2) Towers-Hammond then said he is taking the Computer, I said there was nothing to do with cruelty, & I was actually emailing photos to my lawyers.

- 3) When I was finishing emailing to my lawyers, Towers-Hammond was in the office with me & L. Stageman & Daniel Young were wandering on the 5 acres. Later that day, one of the 3 was often not in the office but on the property.
- 4) I protested on what they were sorting through & taking saying that the documents were not relevant as they were of a personal nature but was continuously assured that I would be given a detailed receipt.
- 5) When they found used needles & syringes, empty vaccine bottles etc.. they indicated I was using drugs illegally & threatened to call in the Police from the Police Station. I told them to do so but they were on the telephone speaking to at least one person whom I assume was a Vet but not a practicing vet as a practising Vet would know what the drugs in the empty containers were used for - even I knew AND it was not illegal as they were administered by my attending Vet or left for me to use on the dog as continuing treatment as prescribed. Those drugs were not available to the Public including to me.
- 6) All my doors were open & during the very hot day, a visitor who stayed out of the house mostly had to come in to drink water & on a few occasions saw on 1, Towers-Hammond rumaging through my hand bag watched by Daniel Young who on seeing her tried to hide something under the papers on the side table & at the same time alerting Towers-Hammond who then questioned this person.
- 7) Both this visitor & I saw Daniel Young on different occasions in my house rumaging through drawers, cupboards etc...

NOTE

On both dates, no receipts were issued for items taken & subsequent receipts were & cannot be considered as receipts as they were vague and did not detail 10% of items removed possibly less than 5% for 22/2
