Daniel Young went "Ump Ump" to alert Jewers - Hammond that I was there, Jewers Hammond turned to me and said "Is this your handbag Mam?"

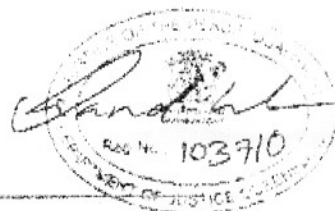
No I said mine is over there do you want to go through that as well.?" No Jewers Hammond replied its not relevant to the case.
