COMPLAINT

QUEENSLAND TO WIT }

THIS IS THE COMPLAINT OF GERALDINE FOOI FONG ROBERTSON

of 17-23 Buccan Road Buccan 4027 in the said State

SWORN/AFFIRMED on 10/09/10 before the undersigned, one of Her Majesty's Justices of the Peace for the State of Queensland, and such Complainant says that ^{Townend ds} Mark Townend CEO of RSPCA 301 Fairfield Road, Fairfield in the State of Queensland

1. **that the intentional conduct of Mark Townend (the Defendant) and his staff** directed at the Complainant has caused the complainant to fear that the Defendant will destroy or damage any property of the Complainant and/or
2. will procure any other person to assault or to do any bodily and probable deadly injury to the said complainant or to any person under the care or charge of the said complainant and/or
3. will procure any other person to destroy or damage any property of the said complainant and the said complainant is in fear of the person complained against namely Mr Townend

The grounds of the complaint are:

1. Mr Townend seized all dogs on my property on the 9th January 2008. Invited the media to trespass on my property and released to the media fabricated / edited video along with words that caused public hatred of me.
2. Mr Townend as CEO of RSPCA then conducted a "save the poodles" campaign to raise money from a sympathetic public, which further vilified me. To ensure there would be public sympathy for my dogs and thus significant donations. Mr Townend as CEO of RSPCA and his staff:
 - a. Supplied to the media video that had been fabricated and interfered with;
 - b. Lied to the public that her dogs had maggots on them and placed maggots onto one of her dogs;
 - c. Lied to the public that the dogs were covered in urine and faeces
 - d. Lied to the public that the dogs were diseased;
 - e. Lied to the public that the dogs were living on their own faeces and urine with a putrid smell;
 - f. Lied to the public that the dogs were neglected;
 - g. Lied to the public that the dogs were malnourished;
 - h. Lied to the public that her dogs were packing and tearing each other apart;
 - i. Lied to the public that her dogs were covered in sores and skin rashes;
 - j. etc...
3. As a result of the conduct of Mr Townend as CEO of RSPCA I suffered:
 - a. More than seven months of death threats and abuse by telephone, by people coming to my property and when in the street.
 - b. I was assaulted by someone coming to my property and had a bottle smashed on my head.



- c. I received nasty letters,
 - d. I had garbage dumped on my property,
 - e. The entrance door to my property was kicked and damaged,
 - f. The Internet filled with vile claims against me that included inciting violence against me.
4. The above mentioned conduct of Mr Townend as CEO of RSPCA resulted in fear and terror and emotional breakdowns with stress related symptoms. I was considerably impaired:-
- a. I had to shop at night to avoid people for fear of abuse from them;
 - b. I had to shop in company;
 - c. I had to become self represented as attrition had caused her financial distress;
 - d. I became debilitated with dread and fear;
 - e. I suffered memory loss and has been unable to cope and has required permanent and constant support.
 - f. I became physically sick and was vomiting;
 - g. I could not go anywhere without company;
 - h. I could no longer go to my club as several people there had threatened and abused me and I was shunned;
 - i. I was shunned by her many customers, people who had purchased their pets from me, my friends and acquaintances.
 - j. I was unable to have witnesses come forward to support me in my Court Appeal in the Magistrates Court for the return of my poodles.
 - k. I was in fear of abuse and had to stop answering the telephone;
 - l. I lived in fear afraid for over seven months to have her lights on at night fearing someone would see I was home and come and carry out their threats to murder me or worst beat me to death as they had said over the telephone.
 - m. In January 2008 my anti depressant medication was increased, and subsequently further increased on two occasions, as was other medication
 - n. I became increasingly depressed, anxious and upset
 - o. I was totally different, isolated myself and had been reduced on occasions to tears;
 - p. I had nightmares which woke me during the night;
 - q. I have to have live in support;
5. Now Mr Townend as CEO of RSPCA has arranged and or condoned others to spy on me and on others in my home and on my property.
6. A recent newspaper article about me/my property is of a nature would inspire further hatred of me and contained blatant lies.
7. Mr Townend as CEO of RSPCA has lobbied the Logan City Council to move against me in meetings and email correspondence obtained from his spies which contain figments of their imaginations invented to support their lies.
8. Late at night I have seen people trespassing on my property and disturbing my dogs.
9. I was and am stalked and lived in fear.
10. Recently there was an increase in anonymous telephone calls and strangers arriving at my home. I fear Mr Townend is mounting another campaign which could result in someone

11. I believe Mr Townend is still spreading malicious statements about me inciting others to harm me all over again.
